I, the Location Owner, hereby grant **(Producer/filmmaker/crew)** the rights to exploit, exhibit, display, reproduce, copyright, print, advertise, televise, broadcast and distribute; including full permission to utilize all recordings in ANY media format, in perpetuity, in relation to the Premises.
4. The Production will provide credit for usage of the Premises.
5. I, the Location Owner, hereby acknowledge and agree that I have no rights in the Production and cannot interfere with the recording, distribution, exploitation, advertising and the finished product of the Production. I, the Location Owner, hereby waive all rights in connection with the Premises (including but not limited to, buildings, structures, goods, signs, logos, art, designs and trademarks within the Premises) for the purposes of the Production in perpetuity.
6. The Production agrees to take proper care of the Premises, and shall leave the Premises in as good condition or better as when entered, reasonable wear and tear excepted.
7. The Production may be permitted to use the Premises on the dates and times noted above. The exact dates may change based on weather conditions or changes in the shooting schedule, in which case we will consult the Location Owner to set new arrangements.

- 9. The Production may, at any time, choose not to use the Premises and will provide written notice and neither of us shall have any obligation towards this document.
